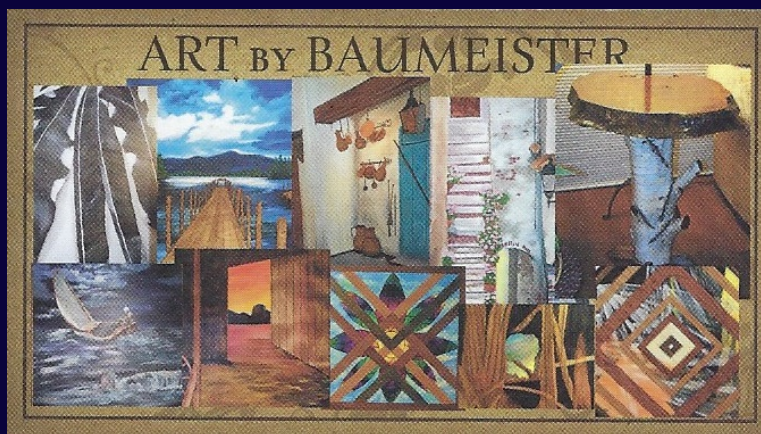

2. Exhibitors are responsible for all set up and removal of their display materials.
3. No mass produced, kit or production work, no representatives are allowed. Works must be for sale and similar in quality and content to the jury images, labeled, limited edition prints are allowed, less than 10% of the booth.
4. A commitment to exhibit is “Rain or Shine”. There can be no refunds. Exhibitors must be open during show hours and be professional.
5. Friday and Saturday morning setup, Artist parking.
6. Deadline - June 30 or until category is full. Categories will be limited to ensure a balanced art show and a fair art market.
